Coeur d' Alene Tribe Public Water System Customers:

Over the past several months, the Coeur d' Alene Tribe Facilities Department has been conducting an inventory of all water service lines for every home that receives its water from one of the Tribe's 3 Public Water Systems in DeSmet, Plummer and the Sub Agency.

The purpose of this is to comply with the requirements under the Lead and Copper Rule Revisions (LCRR) and the Environmental Protection Agency's (EPA's) revisions to the LCRR, by October 16, 2024, to ensure that our systems do not contain lead service lines.

Several methods were used in determining the materials present in all service lines:

- Physical inspection and documentation of service lines at home entry points and at water meter pits
- Date of construction of water service lines
- Date of construction on homes

After inventorying all homes/businesses served by the Tribe's three public water systems located in DeSmet, Plummer and the Sub Agency, it was determined that there is no lead service lines in any of our public water systems.

This is great news for our customers and the Tribe.

Meaning that:

- Our customers can be confident that there is no lead in the service lines
- The Tribe will not need to replace any lead service lines
- We will continue to provide all residents with safe drinking water
